### ACECF AWARDS LCF \$40,000



Altria Companies Employee Community Fund awarded the Lucy Corr Foundation (LCF) a \$40,000 grant for a wheelchair van to transport residents of Lucy Corr Village (LCV) to outpatient doctors' appointments.

LCV recognized the unmet need for transportation services for their frail and disabled elderly population when public transportation did not show or took hours to transport the residents round trip to a single doctor's appointment.

The purpose of the van is to provide efficient, dignified and effective care to the residents while being transported. The Dental Clinic will have access to the van to assist with transporting community members who are disabled and have no transportation to the free dental clinic.

### DELTA DENTAL GRANT

Recognizing the benefits of efforts of the LCDC, Delta



Dental awarded its first grant to LCDC to assist in expanding the free dental services in 2017 to the community into Petersburg and the tri-cities area. The \$10,000 grant will increase clinic hours and staff time to serve more community members.

## ANNABELLA JENKINS FOUNDATION

The Lucy Corr Dental Clinic (LCDC) provided \$206,000 in free dental services in 2016 which was facilitated by a 2015-16 Jenkins grant. The LCF received \$40,000 from the Jenkins Foundation for 2016-17 to expand the work of the LCDC. Five thousand dollars of the funds will be used for LCF Board Development to assist the board in communicating the uniqueness and successes



of the LCDC and other initiatives. A \$2,500 grant from the Virginia Health Care Foundation assisted

the Board in developing a new three year strategic plan, and the Jenkins funds will assist in board development.

## GO FUND ME & CHRISTMAS MOTHER

The Lucy Corr Foundation Board was distressed when they learned before Christmas that there are at least 50 residents at Lucy Corr Village (LCV) who have either outlived their loved ones or who lack family support for the holidays.

Dave Saunders, immediate past president of the board, developed a Go Fund Me initiative which raised \$5,000 by more than 69 donors in 12 days. Additionally, The Christmas Mother, Richmond Times



Dispatch and Community Foundation added \$1,000 for gifts and holiday celebrations. Thanks to the Lucy Corr Wellness Coordinators, board members, community members and volunteers, every resident at Lucy Corr received personalized gifts and participated in celebrations including holiday entertainment and a visit by Santa.

## ANNUAL GIVING

The Foundation received \$9,360 in private donations in response to its 2016 Annual



Giving Campaign. LCV also established an automatic payroll deduction option this year to make it

easier for employees who wished to donate a portion of their earnings to LCF and a dozen LCV employees participated.

## LCF RECEIVES \$20,000 GRANT FROM RMHF

Lucy Corr Foundation received a \$20,000 grant



from Richmond Memorial Health Foundation (RMHF) to support the on-going expansion of the Dental Clinic. RMHF invests financial, intellectual and leadership resources through grant making, strategic initiatives and partnerships with nonprofit organizations, foundations, government, businesses and academic institutions to improve health and healthcare. RMHF support has been instrumental in the Lucy Corr Dental Clinic's modernization, expansion and success as a free dental clinic for the under and uninsured geriatric population at Lucy Corr Village (LCV) and in the surrounding community.



## WALTER W. AND MARIA TERESA REGIRER FOUNDATION

It is acknowledged by health care providers and the arts that the social determinants of health are important aspects of enriched lives for the vulnerable and disenfranchised geriatric population. With this in mind, the

Walter W. Regirer and Maria Teresa Regirer Foundation awarded a \$15,000 grant to LCF for art and music



therapy for residents. The life-long work of the Regirers' was serving the needs of the elderly and aging. Enriched activities stimulate the minds, strengthen the bodies, and boost the spirits of seniors in long term care, assisted living and in the adult day center. According to Today's Geriatric Medicine, art and music have a wide range of health benefits including psychological and physiological healing and can reduce the depression and anxiety that are often symptomatic of chronic diseases and aging. According to behavioral neurologists at the University of California, "while brains age, creative abilities do not necessarily deteriorate."

## ROTARY FUNDS ART PROGRAM

Vice Chair, Danny Smith, attended a Brandermill Rotary meeting to receive a \$500 award for music and art therapy for the LCV residents. This is a reflection of a long term relationship between LCF and Brandermill Rotary. For years, the Brandermill Rotary members have sent long term residents greeting cards for holidays year-round.

### **CULTURAL ARTS CENTER OF GLEN ALLEN PARTNERSHIP**

LCF is sponsoring art therapy for residents in Long Term Care, Assisted Living, and participants in the Adult



Day Center. The Cultural Arts Center of Glen Allen provides artists and supplies for residents to have programming twice a month. Unrestricted donated funds from LCF provide the financial support. A \$100 donation to LCF provides art therapy to seven residents.

### **DENTAL CLINIC PARTNERSHIPS**

The greater Richmond and Tri-Cities' 65 and over population is projected to increase by 81% in 2020. Estimates indicate that over 50% of adults age 65 and over in the region qualify for Medicare or Medicaid which do not cover dental care. A recent study indicates that only 10% of people over 65 have dental insurance. Lucy Corr Village houses the Dental Clinic at no cost to the Foundation. VCU dental students are supervised by 15 volunteer dentists who serve as External Affiliate Instructors. The LCV Dental Clinic Coordinator, Dr. Patricia Bonwell, supervises a clinic dental assistant, VCU dental hygiene students and dental assistant students from Centura College and Fortis College. She also coordinates 18 community partnerships. The Dental Clinic is supported by grants received by LCF and supported by LCV and serves under and uninsured LCV residents and participants and community members.

## DENTAL COORDINATOR NAMED TO VIRGINIA BOARD OF DENTISTRY

The Governor's Office announced that Patricia B. Bonwell, RDH, BSDH, MSG, PhD was appointed by Governor Terry McAuliffe as a Board member to the Virginia Board of Dentistry which regulates the practice of dentistry in the Commonwealth of Virginia. Dr. Bonwell is the Clinic Coordinator for the LCV Dental Clinic which provides free dental services to LCV residents and seniors throughout our community.
