Lucy Corr Free Dental Clinic

In 2018, the LCFDC provided a record breaking \$301,742 in free dental services to Lucy Corr residents and community members who are uninsured and who are unable to afford oral health services which are a key component to overall health, especially for the elderly. Managed by dental clinic coordinator, Dr. Patricia Brown Bonwell, the clinic depends on 17 volunteer dentists, students from VCU Dental School and other local training programs and schools. Financial support from local foundations and individuals make it all possible. Since its renovation in 2012, the LCFDC has provided \$1.366 million in free services.
